AUDITION FOR SECOND OBOE/ENGLISH HORN 2026/05/29 REGULATIONS:

1. - DESCRIPTION OF THE POSITION

SECOND OBOE with ENGLISH HORN OBLIGATION position is offered. This position is governed by the Collective Labour Agreement currently in force.

2. - REQUIREMENTS

- Be at least 16 years old on the date the deadline for submitting applications for participation ends.
- Applicants must hold an advanced degree or equivalent qualification.
- Possess the functional capacity to perform tasks specific to the position.
- Not having been disciplined for a serious offense while performing similar duties.
- Not having been dismissed from the service of any Public Administration through disciplinary proceedings, nor being disqualified from public employment or office.
- Be a national of one of the Member States of the European Union or be a national of a state to which, by virtue of the application of the International Treaties concluded by the European Union and ratified by the Spanish State, the free movement of workers applies, or foreigners not included in this paragraph must provide a Spanish Foreigner Identity Number (FIN-NIE) document prior to the registration date.
- Exceptionally, the President of the selection committee (according to the Soloist of the Section, and for his special interest) may admit to this Audition candidacies that do not have the required degree.

3. - ADMISSION OF CANDIDATES.

All candidates who wish to take part in the selection process must apply on <https://www.muvac.com/vacancy/euskadiko-orkestra-basque-national-orchestra-ny38p5p1> before 2026/04/09.

Required documents and archives:

- Citizens included in the Schengen Agreement: copy of the Identity Document or Passport
- Citizens not included in the Schengen Agreement: copy of the Spanish Foreigner Identity Number (FIN-NIE)
- Copy of advanced degree or equivalent qualification.
- Videos, for applications that start in Phase or Round I

The list of provisionally selected candidates will be posted on the www.euskadikoorkestra.eus website on 2026/04/10. Candidates not included in the list will have 2 days to correct errors or to submit lacking documentation. The final candidate list will be posted on 2026/04/13.

4. - SELECTION COMMITTEE.

The Selection Committee will be composed of Music Director or Euskadiko Orkestra Music Advisor acting as President and of Musicians members of the Staff. The Technical Manager will act as Secretary, with voice but no vote. The General Manager, Stage Manager and a representative of the works council may be present, with voice but no vote.

5.- EXAMINATION SCHEDULE.

- All the Audition process will be managed as it is described at the Orchestra's webpage "Audition's Terms & Conditions document".
- Fase I will be by video audition, with the excerpts from Exercise I, according to the videos candidates have linked at muvac. Candidates who were approved in the video audition for the previous audition in December 2025 will be entitled to proceed directly to the in-person audition on 29/05/2026.
- All videos must be on the muvac profile of each candidate before 2026/04/09, and every candidate must authorize their muvac profile so that these videos can be viewed by the Basque National Orchestra.
- Videos must be full-length, from the front, with the camera at approximately 2.5 meters, with a clear flat background wall, without light or windows in the background, and with the highest audio and video quality.
- The candidates must send a single video, made in a single shot and without any editing. Editing this video will result in direct expulsion from this and future Basque National Orchestra's instrumentalist selection auditions. The work must be recorded in the order described in Exercise I.
- Participants who previously accredit Permanent Contract or Temporary Contract in force (minimum 6 months exercised continuously) in the same position in Orchestra or Professional Ensemble, may request before 2026/03/18 to go directly to the presential Audition on 2026/05/29, with the obligation to be prepared to interpret any work, also those of the video-audition. The approval or not of this request will be communicated to the interested candidacy as soon as possible (limit 2026/03/24) after consulting the President of the Tribunal or person delegated by him, who will respond according to the relevance of the position and group. Candidates who, for this reason, moved on to the December 2025 In-Person Audition will be entitled to move directly to the In-Person Audition on 29/05/2026.
- The list of the admitted candidates to attend presential Audition on 2026/05/29 will be published before 2026/04/20.
- The presential audition will continue the 2026/05/29 at 10:00.
- All candidates must register with their ID or passport from 08:45 to 09:15 on 2026/05/29.
- The orchestral excerpts will be played seated, and concerts will be played standing in the area defined by the Jury.
- The Audition will be carried out in various Phases or Rounds as determined by the Court and works from different Exercises may be mixed (also from Exercise I, video audition). The phases will normally be eliminatory, and at least the first of those carried out in person will be behind the curtain.
- The Jury may ask a candidate to play a specific excerpt or consider an audition finalized when it deems appropriate.

- The Valid candidates who are in the top 3 positions at the end of this Audition, will have access to a support for travel and accommodation expenses, always with receipts justifying different concepts for a maximum amount 350,00€.

6. - HIRING PROCESS.

- The selected candidates shall contact the Orchestra Administration and submit all of the documentation required to formalize the agreement on the dates stipulated by the Orchestra.
- As this is a relief contract, the selected candidate must be unemployed on the day prior to being hired.
- The duration of the contracts will be indefinite, with a six-month trial period. The approximate annual gross salary is 52.200 EUROS. Starting 2026.08.01.
